HOW BILLS IMPACT UTAH FAMILIES


The Legislature considered over 1,000 bills and passed more than 500 into law. Speaker Brad Wilson published a piece to demonstrate how legislation will benefit Utah families. Read the article here/here/.

HISTORIC BUDGET

The Legislature passed the final budget before they adjourned on Friday. This budget is the largest in state history, totaling \$25.97 billion. Significantly, the Legislature made a \$1.2 billion investment in the state's transportation and transit projects and set aside money to develop the Point of the Mountain area. Other highlights include:

- Over \$800 million for Capital projects, including higher education and state buildings.
- \$465.5 million for public education including a 6% increase to the Weighted Pupil Unit (WPU), student enrollment growth, and other items.
- \$64.1 million one-time in FY 2022, \$63.4 million ongoing, and \$20.8 million one-time in FY 2023 for Medicaid growth.
- \$6.5 million ongoing and \$4.0 million one-time for New competitive grant programs for arts, history, and heritage projects.
