IS UTAH THE NEXT DELAWARE?

Utah consistently ranks as one of America's most business-friendly states. Our government prioritizes and passes policies that allow businesses and the economy to flourish, while our top-notch quality of life attracts employees from across the globe. To continue attracting businesses to Utah and cultivating an environment for them to thrive, Rep. Brady Brammer is proposing to run legislation during the 2023 Legislative Session to create a court of chancery in the Beehive State.

History

A court of chancery has a long history, dating back to the King's Chapel in feudal England. In 1796, Delaware created their version of a court of chancery, which still stands as a model today.

What is a court of chancery?


These courts are focused on resolving corporate issues in an expedited fashion to allow businesses to make decisions quickly. Oftentimes, judicial court cases take several months, even years, to go through the full process. In a court of chancery, a decision can be made in a matter of hours or days.

A court of chancery also focuses on allowing business decisions to be made by directors and stockholders of the company, while the court ensures full disclosures were made by each party. The court would determine whether specific enforcement of an agreement is warranted, decide applications for a constructive trust, and issue injunctions in noncorporate matters.

A court of chancery would streamline and expedite business, commercial, and trust cases that may otherwise never receive a hearing. RRJ is excited about the potential of bringing a court of chancery to Utah and we will continue to advocate for innovative, business-friendly policies that will ensure Utah remains the best state for your company to call home.
