

MAY INTERIM

Lawmakers met for the first interim of 2023 to discuss key issues facing the state and begin exploring areas of opportunity. Many committees approved study items and opened bill files to begin exploring various topics.

As part of the Business and Labor interim committee meeting, one of RRJ's clients, The Utah Bankers Association, testified and explained the recent banking crisis and the importance of FDIC insured accounts.

A CLOSER LOOK-

A SPECIAL SESSION

While the Legislature is constitutionally required to meet for a 45-day session beginning the third Tuesday in January, issues often arise that warrant immediate attention, and cannot wait until the next general session. As such, the Governor may call the Legislature into a special session, or the Legislature may call themselves into special session with a two-thirds vote.

The Legislature convened for the 1st special session of the 65th legislature on May 17, 2023 to discuss timely issues impacting the state.

FLOODING

On April 18, 2023, Governor Cox declared a state of emergency due to flooding. This executive order allows the state to utilize additional resources to help with flood mitigation, prevention, and clean up. The Legislature must extend states of emergency if longer than 30 days. The emergency declaration will now expire in mid-August with monthly reports from the Governor to the Legislature.





FUNDING REALLOCATIONS

During each legislative session, the Legislature crafts and passes a budget to meet the needs of the state. However, sometimes issues arise that require a shifting of funds and revenue during the year. Due to the overwhelming snow fall this winter, UDOT exhausted their snowplow removal funds. The Legislature backfilled these budgets and provided additional funds to assist with floods, mudslides, and other emergency issues.

TECHNICAL CHANGES

H.B. 225 *Firearm Possession Amendments*, passed during the 2023 session, had unintended consequences that the Legislature addressed.

Additionally, lawmakers made a slight change to retirement benefits of firefighters, which was an oversight from a 2018 bill. Highlights from the special session can be viewed at le.utah.gov.
