A SPECIAL ELECTION COMING SOON

Congressman Chris Stewart submitted his resignation from the U.S. House of Representatives late last month.

He wrote, "It has been one of the great honors of my life to serve the good people of Utah in Congress. My wife and I have made so many dear friends and memories throughout our journey. I can say with pride that I have been an effective leader for my beloved home state, and I'm honored to have played an important role in guiding our nation through some troubled times. But my wife's health concerns have made it necessary that I retire from Congress after an orderly transition can be ensured. My family and I have been very blessed by this experience. SPECIAL ELECTION

To fill Congressman Stewarts seat as quickly and efficiently as possible, the Governor, Lt. Governor and Legislature have agreed to hold a special election in Congressional District 2 (CD2). In order to ensure a safe and secure election, and avoid voter confusion, municipal elections will be slightly moved and held on the same date as the special election. The municipal primary election will be held on September 5 and the general election will be held on November 21.
