2025 LEGISLATIVE SESSION

The 2025 Utah Legislative Session began on January 21 and will run through March 7. This 45-day session brings a notable shift in representation, with 19 new lawmakers joining the ranks and women now constituting over 30% of the legislature—a historic high for the state.

Key issues on the agenda include immigration and crime, public safety, energy, transportation, public and higher education, water, and election reform.
